The up-graded version of modified website must be supplied and installed within 30 days time from receipt of the work order.

Interested parties may submit their quotation affixing with non-refundable Court fee of Rs. 8.25 latest by 2<sup>nd</sup> February 2023 till 2.00 pm. The quotations will be opened on the same day at 3.00 PM in the office of the undersigned.

## Terms & Conditions:

- 1. Quotation shall be addressed to the Member Secretary, Assam State Biodiversity Board, Aranya Bhawan, 2<sup>nd</sup> Floor, Panjabari, Guwahati.
- 2. The envelop should be super scribed with "Quotation for Refurbishing the ASBB website" and the quotation must be duly signed by the bidder.
- 3. The quotation with inadequate information and those which do not meet the eligibility criteria shall not be considered.
- 4. The service provider should have valid PAN, GST registration number & up to date Trade License (FY 2022-23) and must have to submit photocopy of the same along with the quotation.
- 5. The Board will not entertain any quotations after due date and time of submission. The bidders are advised in their own interest to ensure that their quotations are submitted before the closing date and time.
- 6. For evaluation/ selection of the quotations, decision of the evaluation committee shall be final. No correspondence in this regard will be entertained. The undersigned reserves the right to reject quotations deemed non-responsive.
- 7. Conditional quotations will not be accepted.
- 8. The prices should be quoted in Indian Currency only.
- 9. Payment will be made after completion of the aforementioned work.
- 10. The quoted amount should be inclusive of all prevailing taxes.
- 11. The quotations will be valid for 12 months from the last date of submission.
- 12. The Board reserves the right to reject any or all offers without assigning any reason thereof and no communication will be entertained in this regard.
- 13. Any dispute what so ever, will lie before the Courts having jurisdiction at Guwahati.

- 14. In case of any query, party may visit office during office hours in open days.
- 15. The selected party shall have to deposit performance security i.e. 5% of the total cost of the work in the form of Term Deposit Receipt (TDR)/ Fixed Deposit Receipt (FDR)/Bank guarantee of a scheduled bank in favour of Member Secretary, Assam, immediately after receipt of the work order.
- 16. Experience in similar nature of works is preferable. Proof of such experience to be attached.
- 17. The bidder must have registered office in Kamrup (M) district. Proof to be attached.
- 18. The bidder should not be blacklisted by any government organization in India, an undertaking in this regard to be submitted along with the quotation as per Annexure-II.
- 19. If the selected party failed to do the needful towards the refurbishing works within the stipulated duration and terms & conditions, in that condition, the Board will assign the work to the second lowest bidder.

- ii. In case of a tie, the Board may ask the bidders, who are tied to submit the revised quote with all the conditions of the NIQ remaining unchanged. The bidders who quote the lowest revised quote shall then be declared as the successful bidder.
