# Minutes of 26th Meeting of Assam State Biodiversity Board held on 18th August 2020 at Conference hall of Chief Secretary- Assam, 3rd Floor, C-Block, Assam Secretariat, Dispur

The 26<sup>th</sup> meeting of the Assam State Biodiversity Board was held on 18<sup>th</sup> August 2020 at 12.30 pm, in the Conference hall of Chief Secretary- Assam, 3<sup>rd</sup> Floor, C-Block, Assam Secretariat, Dispur.

A list of the Members and invitees present in the meeting is at Annexure-I.

At the outset, the Board felicitated Mr. Kumar Sanjay Krishna, IAS, Chief Secretary to the Government of Assam as the new Chairperson of the Board.

The Chairperson welcomed everyone present in the meeting and requested the Member Secretary to initiate Agenda-wise discussions.


Agenda item 1: The minutes of the 25<sup>th</sup> Board meeting were confirmed.

Agenda item 2: During the 25th Board meeting, it was suggested to constitute a 'Legal Expert Committee' who will assist the Board in legal matters (NGT & other court matters) & ABS related issues. The Board noted the progress of listing of panel of experts from related background for constitution of the said Committee.

# Agenda item 3: The Board was informed about the following:

- In the matter related to the NGT order dated 09.08.2019 in the OA NO.347/2016, the formation of 2549 Biodiversity Management Committee (BMCs) at all local bodies by 31.01.2020, with the assistance of Panchayat & Rural Dept., GDD and UDD, Assam.
  - a. The present position of constitution BMC in Assam:
    - 2197 (newly constituted) 1. Gaon Panchayat (GP)
    - 185 (constituted before the NGT order) 2. Anchalik Panchayat (AP) =
    - 26 (newly constituted) 3. Zila Parishad (ZP)
    - 40 (constituted before the NGT order) 4. Autonomous council (AC)=
    - 100 (newly constituted) 5. Municipal Board (MB)= 1 (newly constituted) 6. Municipal Corporation (MC)=
  - b. The Board noted that 1067 notifications of newly formed BMCs are yet to receive from the Panchayat & Rural Department, GDD and UDD, Assam as per below:
    - 1. Gaon Panchayat Level= 1054 BMCs notification yet to receive 9 BMCs notification yet to receive Zila Parishad= 4 BMCs notification yet to receive 3. Municipal Board= 1067 BMCs notification yet to receive

c. The Board noted progress on preparation of 2549 People's Biodiversity Registers (PBRs) Total= at all local bodies. The soft copies in respect of all Gaon Panchayat, Zilla Parisad,

Municipal Board and Municipal Corporation were given to P & RD and MBs for adoption and printing of hard copies at their end. A copy of the PBR duly signed by respective BMC Chairman & Member Secretaries to be submitted to ASBB.

- d. The Board noted that as of now, the Board had received 304 numbers of hard copies of PBR and the balance number are yet to be received:
  - 1. Gaon Panchayat Level= 81 hard copies of PBRs received (2166 balance)
  - 2. Anchalik Panchayat level= 122 hard copies of PBRs received (63 balance)
  - 3. Zila Parishad= 5 hard copies of PBRs received (21 balance)
  - 4. Autonomous council= 12 hard copies of PBRs received (28 balance)
  - 5. Municipal Board= 84 hard copies of PBRs received (16 balance)
  - 6. Municipal Corporation= 0 hard copies of PBRs received (1 balance)

### Total=304 hard copies received (2245 balance)

- ii. The Board was informed the following NGT and court cases (apart from OA 347/16):
  - a. OA 472/2018, dated 11/02/2020, Rohit Chowdhury vrs Union of India & Ors. related to Deepor Beel and Boragaon solid waste dumping ground.
    - The Board noted that no actionable activities for ASBB were listed in minutes of the meeting held on 22/06/2020.
  - b. Appeal No. 04/2020/ EZ with IA No. 34/2020/EZ, Bimal Gogoi & ANR vrs Union of India & ANR related to Biodiversity Impact Assessment study at Dibru Saikhuwa NP.
    - The Board noted that no 'Biodiversity Impact Assessment' study was conducted by ASBB at Dibru Saikhuwa NP. Accordingly, an affidavit was also filed on 11/08/2020.
  - c. One Man Enquiry Committee.
    - The Board noted that all required documents sought were submitted to the One Man Enquiry Committee.
  - d. NGT Order dated 24.06.2020 in the matter of O.A No. 44/2020/ EZ (Bonani Kakkar Vs Wild Life and Environment Conservation Organisation vs. Union of India Board & Ors.)
    - The Board noted that all required documents sought were submitted to the NGT Expert Committee on 03/07/2020.
- iii. The Board was informed about the submission of the proposal of formation of State Level Peoples' Biodiversity Register (PBR) Quality Evaluation Monitoring Committee with 5-7 members to the Government of Assam.
- iv. The Board noted the completion of 9<sup>th</sup> and 10<sup>th</sup> Batch of Biodiversity Research Associate Program (BRAP). It was also informed that 18 Anchalik Panchayat PBRs were completed by 18 Fellows and 4 Fellows were assisted in data entry works in the test trial of 'Digital PBR Database' under the 9<sup>th</sup> Batch BRAP. Similarly, 10 Fellows were engaged under 10<sup>th</sup> batch to assist the Board in PBR preparation of newly constituted BMCs from secondary data available for compliance of the NGT order dated 09.08.2020.
- v. The Board was informed about the NIO where the Board invited research proposals from Individuals/ Organization/ Institutions for conducting theme based research projects for

small (up to 2 lakh) and medium grants (up to 5 lakh) published on 07/12/2019. Accordingly, following proposals were received:

- 1. Small grants (up to 2 lakh)= 6 Proposals received
- 2. Medium grants (up to 5 lakh) = 21 Proposals received
- The Board noted that the preliminary evaluation was completed on 10/06/2020 by the Internal Evaluation Committee and shortlisted 3 proposals for Small grants and 8 proposals for Medium grants.
- It was also informed that the final evaluation will be done by RAC in due course.
- Based on the recommendation of the RAC, one (1) grant in each category will be awarded.
- vi. The Board was informed about the NIO published on 22/12/2019 for preparation of Majuli BHS Management Plan. Due to insufficient bidders the said NIO re-advertised on 16/02/2020. An Evaluation Committee was constituted and evaluated the proposals on 10/06/2020. The Committee recommended the following for assigning the task for preparation of Majuli BHS Management Plan:
  - Integrated Development Organization, Bhopal
    - The Principal Investigator of the consultant firm is a Retd. Associate professor of Indian Institute of Forest Management, Bhopal.
    - Total Cost:

3.00 lakh.

- > Implementing Agency: Integrated Development Organization (IDO).
- The Board approved the recommendation of the Evaluation Committee to assign the task of preparation of Majuli BHS Management Plan to the Integrated Development Organization, Bhopal.
- vii. The Board noted completion of the project 'Plant Diversity Assessment of Dima Hasao district' in Assam.
- viii. The Board noted the completion of the Digital Peoples' Biodiversity Register (PBR) Database on 13/01/2020. The Board was informed that at present the database is being hosted at AMTRON mini data centre. The Board approved to pay Rs. 60,000/- to AMTRON annually to continue the hosting at AMTRON mini centre.
- ix. The Board was informed that International Day for Biological Diversity,  $22^{nd}$  May, 2020 event was celebrated through various online competitions like essay, poster and paintings, webinar series, publishing radio jingles etc. on the theme of "Our Solutions are in Nature". The event was sponsored by National Biodiversity Authority (NBA).
- x. The Board was informed that 5 capacity building and awareness workshops for strengthening BMC members of BTC and Karbi Anglong Autonomous Council were organized during November 2019 covering 5 BMCs.
- xi. The Board was informed that the accounts of the Board for FY 2014-15 to 2017-18 were audited by the Accountant General (AG). The Board also noted that out of 15 nos of POS of

the audit, so far, replies of 8 POS have been sent and the rest 7 nos of POS will be submitted soon.

xii. The re-constitution of the Research Advisory Committee (RAC) on 13/08/2020 was noted by the Board. The RAC was constituted to examine the research project proposals received by the Board and make recommendations. It consist of the following members:

1. Dr. P. C. Bhattacharjee, Expert Member- ASBB: Chairperson 2. Conservator of Forests (Wildlife), Assam: Member 3. Dr. Bibhab Kr. Talukdar, Expert Member- ASBB: Member 4. xiii. It was informed to the Board that the National Biodiversity Authority (NBA) have been organizing monthly review meetings of SBBs since September 2019 and the Board has been attending the same by providing all required information related to status of BMC constitution and PBR documentation works in Assam.

xiv. The Board was informed that a proposal of Rs. 24.00 lakh was submitted to the CAMPA, Assam during June 2020 for updation of newly prepared 1st draft PBRs, which required field validation. The CAMPA, Assam later informed that the proposal will be placed in next State Level Executive Committee (SLEC) for consideration.

xv. The Board noted that the Annual Report for FY 2018-19 was under process for publication.

xvi. The Board approved the following activities to be undertaken in the APFBC phase II, subject to the sanction and release of grant:

- 1. Strengthening of Biodiversity Management Committee (BMC)
  - ✓ Awareness generation of Anchalik Panchayat BMCs.
  - ✓ Updation of Peoples' Biodiversity Registers (PBRs) and other PBR related works.
- 2. Development and implementation of Biodiversity Management Plans.
- Development of Access and Benefit Sharing guidelines and its piloting.



#### Agenda Item 6:

- Regarding implementation of Access and Benefit Sharing (ABS) mechanism in Assam, the following were informed to the Board:
  - a. The National Biodiversity Authority (NBA), Chennai, directed all the SBBs in the last meeting held on 30/07/2020, to start implementing the ABS Regulation 2014 at the earliest.
  - b. This would help in the receipt of the ABS amount which can be ploughed back to the Benefit claimers or the Biodiversity Management Committees to help in conservation.

- c. This would also make the BMCs and local people financially stable to assist biodiversity conservation activities and sustainable utilization of biological resources to support their livelihood.
- d. The NBA also directed to spread awareness generation on ABS through print media highlighting the facilitative role played by the SBB in according approvals for commercial utilization and trade of biological resources.
- e. The States are to document the list of traders and manufactures involved in trade/commercial utilization of biological resources to ensure that the provisions of the BD Act are compiled by these entities.
- ii. The Board approved the following steps to be taken up for implementation of ABS Regulation, 2014 in Assam:
  - a. Awareness generation on ABS through print/electronic media for wide outreach, highlighting the facilitative role played by the SBB in according approvals for commercial utilization and trade of biological resources.
  - b. A draft Standard Operating Procedure (SoP) for commercial users of biological resources shall be prepared.
  - c. ABS application fee of Rs. 1000/- to be prescribed by 'Board' for access to biological resources for commercial utilization as per Rule 18(1) of the Assam Biodiversity Rules 2010.
  - d. The Board shall formulate and notify the guidelines and describe the benefit sharing formula, as per Rule 22 (1) of Assam Biodiversity (Amendment) Rules 2019.
  - e. The Board shall adopt the 'the ABS Regulations/Guidelines 2014 notified by National Biodiversity Authority/Govt. of India on 21.11.2014 under Section 21(4) of BD Act 2002, as followed by other SBBs.

### Agenda Item 7:

- i. Sitting Fee of non- official members of the Board.
  - a. The Board directed to revise the sitting fee of non-official members from Rs. 500/- per day (Rule 6.4 of the Assam Biodiversity Rule 2010) to Rs. 2000/- per day.


