### **Notice Inviting Quotation**

The Assam State Biodiversity Board (ASBB) invites sealed quotation from reputed interested parties affixing with non-refundable Court fee of Rs. 8.25 for the following work of Assam State Biodiversity Board:

# Specification of work: Printing and supply of 129 numbers of People's Biodiversity Registers (PBRs)

- i. Printing: Multicolour printing including photo incorporation, binding etc.
- ii. Size: Legal size.
- iii. Quantity required: 129 numbers of PBRs as per the details at Annexure-I.
- iv. Total numbers of pages: 30192 pages of Legal size (excluding cover page, approximate;  $\pm$  300 pages).
- v. Number of B/W pages: 22281 pages of Legal size (excluding cover pages, approximate;  $\pm$  100 pages).
- vi. Number of colour pages: 7911 pages of Legal Size (including cover pages, approximate;  $\pm$  100 pages).
- vii. Paper- Inside pages: 100 GSM paper.
- viii. Cover lamination: Matt finish.
- ix. Binding: Hard binding.

(Note: The PBRs will be supplied from this office.)

Interested parties may submit their quotation latest by 15/11/2025 till 2.00 pm.

The quotations will be evaluated and opened on the same day at 3.00 PM in the office of the undersigned. In case, the day happens to be a holiday or unavoidable circumstances arises, the quotations will be opened in the next working day.

#### **Terms & Conditions:**

- 1. Quotation shall be addressed to the Member Secretary, Assam State Biodiversity Board, Aranya Bhawan, 2<sup>nd</sup> Floor, Panjabari, Guwahati.
- 2. Sealed quotation should be submitted separately in 2 (two) bids:
  - i. **Technical Bid:** Following documents are to be submitted along with the Technical Bid:
    - a. Non-refundable Court fee of Rs. 8.25.
    - b. Samples of paper mentioned above.
    - c. Sample copies of recent such works (such as; printing of any Government reports, magazines, annual reports, financial reports, brochures etc.) already printed by the firm in the year 2022 to 2025 etc. At least one sample copy should be submitted along with the Technical Bid.
    - d. Valid and authenticated photocopies of PAN, GST and Trade license.
    - e. Valid and authenticated certificate of Government registration.
  - .f. Valid and authenticated document having registered office in Kamrup (M) district.

- ii. **Financial Bid:** Sealed Financial Bid is to be submitted in the prescribed format at **Annexure- II** separately, and the same will be considered/ opened of those firms/ parties who would duly qualify in the Technical Bid i.e. who have submitted each and every required documents along with the Technical Bid.
- 3. Both the 'Bids' shall be sealed separately and submitted in a common sealed envelope superscribed as 'Printing and supply of 129 numbers of People's Biodiversity Registers (PBRs)', and addressed to 'The Member Secretary, Assam State Biodiversity Board', Aranya Bhawan, 2<sup>nd</sup> floor, Panjabari, Guwahati-37.
- 4. The PBR details with total page numbers, B/W pages and colour pages are at **Annexure-I**. The Bidder may refer the details list before quoting any figure.
- 5. The quotation with inadequate information and those which do not meet the eligibility criteria shall not be considered.
- 6. The Board will not entertain any quotations after due date and time of submission. The bidders are advised in their own interest to ensure that their quotations are submitted before the closing date and time.
- 7. For evaluation/ selection of the quotations, decision of the evaluation committee shall be final. No correspondence in this regard will be entertained. The undersigned reserves the right to reject quotations deemed non-responsive.
- 8. Conditional quotations will not be accepted.
- 9. The rate should be quoted in Indian Currency only and inclusive of all taxs and cost.
- 10. Payment will be made after completion of the aforementioned work.
- 11. The rates should be valid for 12 months from the last date of submission.
- 12. The Board reserves the right to reject any or all quotations without assigning any reason thereof and no communication will be entertained in this regard.
- 13. Any dispute what so ever, will lie before the Courts having jurisdiction at Guwahati.
- 14. In case of any query, party may visit office during office hours in open days.
- 15. The bidder should not be blacklisted by any State/ Central government Department or . Agency/PSU.
- 16. The final printing of these 129 PBRs will be done in consultation with the ASBB and soft copies of these 129 PBRs along with the photographs will be provided by the ASBB.
- 17. The final draft of these 129 nos PBRs must be authenticated by the ASBB office before final print.
- 18. In the event of defective execution of work leading to rejection of work, the firm will have to re-print the same and carry out corrections and improvements as may be advised and no extra cost/charges shall be entertained against such work.
- 19. These PBRs has to be supplied to this office within 30 days from the issue of work order.
- 20. The selected party shall have to deposit performance security i.e. 5% of the total cost of the work in the form of Term Deposit Receipt (TDR)/ Fixed Deposit Receipt (FDR)/Bank guarantee of a scheduled bank in favour of Member Secretary, Assam, immediately after receipt of the work order.
- 21. If the selected party failed to do the needful within the stipulated duration and terms & conditions, in that condition, the Board will assign the work to the second lowest bidder.

# **Selection Procedure:**

- i. The selection shall be done on the basis of lowest rates quoted by the technically qualified bidders, and lowest quoted bidder will be declared as successful (L1) bidder.
- ii. In case of a tie, the Board may ask the technically qualified bidders, who are tied to submit the revised quote with all the conditions of this NIQ remaining unchanged. The bidders who quote the lowest revised rate shall then be declared as the successful bidder.
